#### **Cars obstructing view at junction of Springfield Lane and A682.**

Mrs. H. Hughes reported that cars parking on the footpath were still obscuring the view when exiting Springfield Lane onto the A682. PCSO S .Clarke had previously been in contact with the but little had changed.

PC.A. James said that any parking tickets would have to include all those parking on the footpath in the Parish.

Several Councillors thought that the provision of a toilet for public use, was a condition on the original Planning App. These children also caused problems by throwing small stones at two horses in a field.

Mr C. McEvoy reported that several children had been messing about on the reservoir wall opposite Cotton Row and the following morning all the top stones had fallen off.
