## **Police Matters.**

### **Cars obstructing view at junction of Springfield Lane and A682.**

Mrs,H.Hughes reported that there were still 3 vehicles parking on the footpath, obscuring the view. PCSO Clarke had visited the residents concerned and was still monitoring the situation.

## **Speeding in the Parish.**

PCSO S. Clarke had forwarded a link to the clerk, for reporting this and the clerk had done this. Both, PCSO Clarke and Cllr. J Inckle would be meeting the deputy police crime officer, (Mr. Pratt) in the next few days and would liaise on this.

**Resolved.** - The clerk would contact the LCC, with regard to the yellow community concern signs and the activation record of the speed camera at Clowbridge.

## **Moorland View School Signage**

The Clerk reported that she had contacted the LCC again and their reply had said that they could not support the Manager of the Home putting his own signs up.

Mr. W. Brindle reported that Moorland View could be liable from a safety aspect if it erected any signs on the main road and the Parish Council could ask for a crossing point here for pedestrians.

## **Clowbridge Playground**

The litter bin had not been replaced.

**Resolved-**The clerk pass the documentation to Ms. A. Hayworth, who would take up the matter with the Green Spaces Dept at Burnley Borough Council.376

## **Clowbridge Reservoir-Gambleside Trail**

## **Tree planting on the mounds at Clowbridge**

The clerk reported that some native species of trees were to be planted here, as part of a larger scheme, including surrounding Boroughs., This was part of Her Majesty the Queen's Platinum Jubilee Celebration. The date was not yet decided and depended on the weather. Council members could take part, any other volunteers and the children from Moorland View.

The Council welcomed this.

## **Clowbridge and house numbering**
